We'll begin with the update from the Legislative Session.

Legislative Update:

A number of bills passed during the 2012 Legislative Session have been signed into law by Governor Scott and may affect your medical license/practice. Some of those bills are highlighted below. A review of the full text of the bills can be accessed at the links provided and will better assist you with understanding changes in the law that might impact your medical license/practice.

Enrolled CS/CS/HB 787, Engrossed 1 -Controlled Substance Prescribing and Pain Management Clinics

Section 31 of this bill amends section 456.44, Florida Statutes (F.S.), the registration and standard of practice requirements for health care practitioners who prescribe controlled substances for the treatment of chronic nonmalignant pain. Sections 32 and 33 of the bill amend sections 458.3265 and 459.0137, F.S., with regard to Pain Management Clinics. The provisions of this bill become effective July 1, 2012.

Enrolled CS/CS/CS/HB 1263 - Liposuction

Sections 94 and 95 of this bill amend sections 458.309 and 459.005, F.S., with regard to the performance of certain liposuction procedures. This requirement is effective January 3, 2013.



Governor Scott Appoints New State Surgeon General

On April 27, 2012, Governor Rick Scott appointed Dr. John H. Armstrong, MD to serve as Florida's State Surgeon General and Secretary of the Florida Department of Health, relieving Interim State

Surgeon General Dr. Steven L. Harris, MD, M.Sc from the duty. The previous State Surgeon General, Dr. Frank H. Farmer, MD, announced his resignation in March, which became effective immediately following the 2012 legislative session.

"Dr. Armstrong is recognized as a national expert in medical team training and public health preparedness for disasters, and his leadership will be a great asset to the citizens of Florida," Governor Scott stated.

After receiving a Bachelor's Degree in Economics from Princeton University, Dr. Armstrong continued on with his education at the University of Virginia School of Medicine to obtain his Medical Degree. He completed his General Surgery Residency at Tripler Army Medical Center in Hawaii and his Fellowship in Trauma/Surgical Critical Care at the University of Miami/Jackson Memorial Medical Center. He also completed the Master Educators of Medical Education program at the University of Florida.

In December of 2010 at the University of South Florida (USF), Dr. Armstrong became the Chief Medical Officer of the Center for Advanced Medical Learning and Simulation (CAMLS); additionally, he was named as an Associate Professor of Surgery with the USF Morsani College of Medicine. Prior to his service at USF, he served as a member of the Council on Public Health with the Florida Medical Association.

He is also currently a member of the Board of Governors for the American College of Surgeons and the National Residency Review Committee for Surgery.

Dr. Armstrong is also a 17-year veteran of the United States Army Medical Corps, graduating from the U.S. Army Command and General Staff College and working his way up to the ranking of Colonel. During his service, he developed and implemented an award-winning two-week training program in trauma care for military medical units deploying to Iraq and Afghanistan.

"I am honored by the opportunity to serve as Florida's State Surgeon General and look forward to advancing the department's mission to make Florida the place to live, work, and play by ensuring the health and well-being of Floridians," Dr. Armstrong announced, following his appointment.

Dr. Armstrong's service as State Surgeon General is set to begin on May 23, 2012.

Did you know?

It has come to the attention of the Board that some medical practices are asking patients to sign documents wherein the patient agrees to "waive standards of care" established in the Board rules or elsewhere. The signing of such a document does not relieve the treating physician from complying with all Florida laws. Such a legal obligation would include compliance with all standards of care whether set forth in statute, rule or general law.

Federation of State Medical Boards Holds 100th Annual Meeting

Board of Medicine members, James W. Orr, Jr. MD, FACOG, FACS, Robert Nuss, MD and Mr. Bradley M. Levine represented Florida at The Federation of State Medical Boards' (FSMB) 100th Annual Meeting, held on April 26 – 28, 2012 in Ft. Worth, Texas. National experts in the field of medical licensure and discipline were in attendance to present and discuss a wide range of subjects relevant to medical regulators including but not limited to updates in medical licensing examinations, maintenance of licensure, national licensure, medical education. graduate social networking, pain management, telementoring and physician reentry. Dr. Regina Benjamin, MD, MBA, Surgeon General of the United States, delivered the welcoming remarks and was honored with the FSMBs' Lifetime Achievement Award.

One hotly debated topic at the annual meeting was the Proposal for a Platinum Standard for Medical

which involves the creation of a new standard of medical licensure intended to make rapid licensing available to the highest caliber of licensed physicians across the country.

Another important topic discussed was the FSMB's Maintenance of Licensure (MOL) initiative which supports a system of continuous professional development for physicians as a condition of license renewal. The FSMB is developing pilot projects with several states to test implementation of the MOL concept, including having physicians who are already engaged in Maintenance of Certification (MOC) recognized as being substantially in compliance with any state's

MOL program. For those physicians not specialty-board certified or not engaged in MOC for whatever reason, MOL could be achieved through completion of a wide range of activities, including CME, that many physicians already complete. Florida would not be able to adopt either the Platinum Standard or MOL without significant statutory changes; however, these are topics that the Florida Board of Medicine will continue to monitor.

ALERT: Florida DOH Warns of Fraudulent Correspondence

It has been brought to our attention that an unknown party has been sending out fraudulent letters to pharmacies claiming to be from the Department of Health's Investigative Services. These forgeries are of poor quality and should be easy to detect; however, to better help you identify them, we have placed an example of one of the fraudulent letters on the Board of Medicine website, on the front page under "Hot Topics."

Indicators of Forgery

- Letterhead is incorrect, footer is missing entirely
- Significant number of grammatical errors, misspellings, poor choice of words
- No return address
- Phone number for questions incorrect, not Board office number

April 2012 Board Meeting Highlights

The April 2012 Board of Medicine Meeting was held at the Hyatt Regency Hotel on the Jacksonville Riverfront on April 13th and 14th. The Board heard 49 disciplinary cases against both physicians and physician assistants; below is a breakdown of each type of disciplinary action that was imposed:
