RULES *and* AMENDMENTS *for* FY 14-15

During FY 14-15, the Board drafted new rules and amended several existing rules in a continued effort to improve the quality of health care, increase patient safety, and to improve efficiency. Some rule highlights are noted below:

BOARD *of* MEDICINE RULES

Rule 64B8-1.007, FAC - List of Approved Forms; Incorporation.

This rule was modified multiple times throughout the fiscal year as Board of Medicine forms were amended.

Rule 64B8-3.002, FAC - Application, Certification, Registration and Licensure Fees

This rule amendment implemented a licensure fee in the amount of \$424, and allows the fee to be waived if the applicant is not compensated for his or her services. This rule amendment became effective on September 10, 2014.

Rule 64B8-3.003, FAC - Renewal Fees

This proposed rule amendment clarifies that the correct statutory renewal fee for house physician is \$200.

Rule 64B8-4.009, FAC - Applications

This rule was amended to incorporate the revised intern/resident/fellow in house physician application into the rule. Effective May 19, 2015.

Rule 64B8-8.001, FAC - Disciplinary Guidelines

This rule was amended to provide the appropriate disciplinary guidelines for violations regarding physicians who fail to comply with the educational requirements before ordering low-THC cannabis for patients.

Rule 64B8-8.017, FAC - Citation Authority

The proposed rule amendment creates a citation violation in the amount of \$1000 for failure of a designated physician in a pain management clinic to submit data required by Section 458.3265(2)(j)2 and to require submission of the delinquent data within 30 days.

Rule 64B8-9.009, FAC - Standards of Care for Office Surgery

The amendments clarify the various levels of office surgery, update the anesthesia monitoring guidelines, clarify the training requirements, and changes the equipment and supplies required in an office surgery facility. Effective April 6, 2015.

Rule 64B8-9.0091, FAC - Requirement for Physician Office Registration; Inspection or Accreditation

This rule was amended to clarify registration requirements for office surgery facilities. Effective October 24, 2014.

Rule 64B8-9.0141, FAC - Standards for Telemedicine Prescribing Practice

This rule was repealed after implementation of Rule 64B8-9.0141, FAC – Standards for Telemedicine Practice. Effective October 26, 2014.

Rule 64B8-9.0141, FAC - Standards for Telemedicine Practice

This rule was amended to merge some of the language from Rule 64B8-9.014, FAC - Standards for Telemedicine Prescribing Practice. Effective October 26, 2014

Rule 64B8-10.003, FAC - Costs of Reproducing Medical Records

During this fiscal year, the Board continued to work on drafting amendments to require all parties to pay \$1 per page.

Rule 64B8-11.001, FAC - Advertising

The Board approved the American Board of Vascular Medicine as an entity for the purpose of advertising specialty certification. This rule was amended to add this entity to the list approved for this purpose. Effective March 2, 2015.

Rule 64B8-12.005, FAC - Procedures

The proposed rule amendment clarifies the requirements with regard to financial responsibility and incorporates the revised financial responsibility into the proper rule.

Rule 64B8-13.005, FAC - Continuing Education for Biennial Renewal

This rule was amended to permit a supervising physician to receive CME credit for each physician he or she supervises or monitors. Additionally, the amendment clarifies that only five hours may be used to satisfy the risk management requirement but that any additional hours can satisfy the general CME requirement. Effective October 26, 2014.

Rule 64B8-30.003, FAC - Physician Assistant Licensure

The rule was amended to incorporate the revised physician assistant licensure application form into the licensure rule. Effective February 22, 2015.

Rule 64B8-31.005, FAC - Anesthesiologist Assistant Protocols and Performance

The rule was amended to incorporate the revised Anesthesiologist Assistant protocol form into the Board's rule. The form was also amended to clarify the number of assistants that can be supervised by an anesthesiologist. Effective March 17, 2015.

BOARD, COMMITTEE *and* REGULATORY MEETINGS FY 14-15

To increase efficiency and reduce costs, the Board of Medicine continued the use of conference calls as an alternative for those meetings that do not require personal appearances, as well as combining meetings or holding meetings in conjunction with Full Board Meetings.
